We support indigenous evangelists who we have trained under our ministry to do the work of evangelism.

The Global Field Evangelism network of national evangelists exists in 9 countries in Africa: Burundi, Democratic Republic of Congo, Kenya, Malawi, Nigeria, Rwanda, Tanzania, Uganda, and Zambia. These teams work all year round preaching in villages, market-places, prisons, high schools, colleges, and at Jesus Film shows. They are funded to do these meetings and receive personal support from the US ministry of SWEA. This year they conducted 23,541 separate meetings. They preached to over 21,900,000 people and recorded over 19,000,000 individuals who indicated a decision for Christ. They also held 223 seminars where they trained 25,446 pastors, evangelists, and lay-people on how to do personal evangelism and how to conduct church-wide and mass evangelism events. Global Field Evangelism shipped 15,000 copies of a graphic novel of the Bible to Tanzania to be distributed to school libraries in Tanzania, and we shipped 3,500 copies of the same book to Uganda. We printed 2,000 copies of the Real Faith book in Nigeria. We purchased PA equipment for Tanzania, Nigeria, Kenya, Zambia, and Malawi. We also provided food for the refugee camps in Rwanda.

Shad Williams Evangelistic Association did not do any overseas campaigns this year. Shad and Sheila's daughter died in January, after a long illness, and they needed time off of their travel schedule. The day to day work of administrating the ministry still continued and funds that would have gone into their travel expenses for international projects was invested directly into the expansion of the Global Field Evangelism work. We added Uganda as a new field in 2024. We also worked on additional book distribution for overseas ministry.
